New business is a Pinterest paradise

Meghan Wellsbury isn't sure how Craft Happy came to be, but she's thrilled that it did.

"I'm not really sure how we ended up in crafts other than we're both craft fanatics," the business owner says about Orangeville's newest craft shop.

Wellsbury and her sister, Alyssa Elstone, have had a few other independent business ventures in the past, including making candy bouquets, jams, and organic cookies, but none of them stuck. Finally, the duo thought up a business that solved a problem they both experience — how to get rid of leftover craft supplies without throwing them in a landfill?

"We both have a very short attention span when it comes to crafts," Wellsbury says. "I was a knitter for years and I had all the supplies and then I decided 'I'm not doing this any more' and I got rid of all my supplies. Then I decided I'm going to do something else and I buy all new supplies. We thought we can not be the only people who do this, we can not be the only people who have a room full of craft supplies we're not using, and you just don't want to throw it out."

"The hardest part is praying that we can keep this going," Wellsbury says. "Rent is not cheap in this town. We've got great customers, people who just come in and support us so much, but it's making sure there's new product in the store, it's making sure we can do this for as long as we can and eventually bring in an income."

Wellsbury says Orangeville is a great place to be a business owner, but despite the supportive community, start-ups should have a plan in place to make sure they can survive their worst day.

"Plan it out. Figure out your worst day, if this is the only way you're going to bring money in, because at the end of the day it's all about bringing money in," she says. "You need to pay for the rent and put the lights on, or if you're doing it from home you need to be able to feed your family."

Wellsbury says she and Elstone are going to do their damndest to make sure Craft Happy is around for a long time and she thinks their ability to cater to their customers' niche needs and the culture in the town will help them succeed.

"Our downtown is growing, and we've just got this awesome culture in this town where people want to try new things and we take pride in what we have," she says.
